

# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.carmfogt.net](http://www.carmfogt.net) and Fine Art by Carm Fogt and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Fine Art by Carm Fogt include [www.carmfogt.net](http://www.carmfogt.net). The Fine Art by Carm Fogt website is a Fine art promotion and sales site. By using the Fine Art by Carm Fogt website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, Fine Art by Carm Fogt may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Fine Art by Carm Fogt's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
